RESIDENCY CHANGES

The 2018-2019 catalog lifted the requirement that the last 25% of a student's degree requirements must be taken at UNC Charlotte. This 25% requirement for the degree now encompasses the student's entire UNC Charlotte career. However, the requirement for completing the **last** 12 credit hours in the student's major field of study is still a restriction worth closely monitoring. This requirement is being enforced within the major block of the degree audit and could affect a student's graduation. A waiver can be submitted by academic petition from the student's Associate Dean or for transient study by checking the waiver box on the form.

JANUARY 31, 2019—DEADLINE FOR ALL COURSE AND CURRICULUM PROPOSALS TO BE LAUNCHED AND APPROVED BY ORIGINATOR VIA [CURRICULOG](#).

(Curriculum changes requested by this date will be included in the 2019-2020 Undergraduate or Graduate Catalog if they reach final approval by the published deadline date of approximately 5/1/19. The likelihood of reaching final approval in time for publication in the Catalog increases the earlier the proposal is started by the Originator.)

TUITION SURCHARGE

Reminder that students are surcharged 150% tuition (not fees) for greater than 140 attempted hours and 8 semesters. Warning emails will be sent Friday, December 14.

MAJOR/MINOR GPA CALCULATION

As we implement the standardization of major/minor GPA calculations, as defined in the memorandum from the Office of the Provost on October 1, 2018, we also want to honor prior agreements that were made between advisors and students. **Academic petitions to exclude specific courses will only be accepted up to the start of the Fall 2019 term. After the start of Fall 2019, these types of petitions will not be processed.** All majors and minors have a minimum GPA requirement of 2.0, and some programs define greater GPA graduation requirements. To improve a major or minor GPA, students may take additional coursework of the major/minor prefix.
