OFFICE CLOSURE

Since Niner Central was established, the Office of the Registrar has been transitioning services previously handled at our counter window to Niner Central. Most of this transition occurred in 2017 and 2018 when Niner Central opened its doors. A few services remained with the Office of the Registrar. We have reviewed traffic patterns and reasons for visiting for a couple of years now. The volume of visitors has dwindled over time. As a result, on June 1, the Office of the Registrar will finalize our transition and will no longer operate its counter window. PREREQS NOT MET - REGISTRATION DROP

On Thursday morning (5/19), after end-of-term processing was complete, only summer full-term (FT) and 1st half-term (H1) courses for which students did not have the prerequisite requirements were dropped. We will run again prior to the summer 2nd half-term (H2) and again before the fall term. Courses in H1 and H2 were temporarily granted concurrency but that will be removed again after the H1 add/drop has ended.

>7 HOURS IN A SUMMER TERM

We have warned and dropped students' courses (*starting with their last registration*) in summer 1st half term (H1). We will continue to do so through the end of H1 add/drop. In an effort to provide students more time to submit petitions, we are not dropping summer 2nd half term (H2) until closer to the start of H2. This requires constant monitoring because students can add their schedules back immediately after their drop.
