#### **SPRING 2020 SPECIAL PROBATION**

A student on academic probation whose cumulative GPA remains below 2.0 this spring will be placed on special probation. A student whose cumulative GPA remains below 2.0 at the end of fall will be suspended from the University, unless the student earns a term GPA of 2.3 or higher in the fall term which places the student in a "continued probation" status. Special Probation is noted on the student's permanent academic record. The student would be allowed to continue into summer and/or fall.

# NEW COURSES - CLINICAL & PRACTICUM MAKE-UP

These courses were created to begin this summer and allows students to finish their clinical and practicum hours that they were unable to complete due to COVID-19 impacts. These courses will serve only to indicate continued study and attach hours.

## **GRADE REPLACEMENT**

Undergraduate students will have the ability to use grade replacement to replace any grade received -- P/N or a standard letter grade -- earned in Spring 2020. Undergraduate courses in Spring 2020 will be excluded from the maximum two courses allowed for grade replacement.

# **CHANGE TO CREDIT BY EXAM INSTRUCTIONS**

We have streamlined the process to reduce steps for students. The new process is as follows:

- 1. Student downloads form and submits completed form to instructor/department
- 2. Department approves and returns form to student
- 3. Student pays via Marketplace
- 4. Student sends receipt/proof of payment and form to Instructor/department
- 5. Department submits completed form/receipt to Registrar

### PROOF OF ATTENDANCE (BEGINNING IN SPRING 2020)

All instructors will be required to enter the last date of attendance/participation for all students with failing (F) or unsatisfactory (U) grades. In support of the Office of Student Financial Aid and federal reporting needs, we have worked together to develop a means to collect a student's last day of attendance for F and U grades. The regulations require us to determine whether the student attended class and whether the grade was earned or a result of attendance.

### FORUM FOLLOW-UP: INTERNATIONAL SPONSOR ENROLLMENT VERIFICATION FORMS

Our office is working on improving the process for completing sponsor enrollment verifications for international students. Currently, there is some information on these verification forms that the Office of the Registrar cannot verify alone. To increase the accuracy of these forms, our office will work with the student's academic advisor (via email) in verifying all applicable information, before submitting the completed form to the sponsored agency. This new process will be for international sponsor enrollment verification requests from UNC Charlotte *degree-seeking students*.

# PASS/NO CREDIT AND PASS/UNSATISFACTORY GRADING OPTIONS (SPRING 2020)

Undergraduate students earning an A-D grade, will have the ability to elect a P (Pass) and for those earning a grade of F, will have the ability to elect an N (No Credit) for this spring. Graduate students earning a grade of A-C, will have the ability to elect a P (Pass). Students earning a U grade will retain their U grade and will not have the ability to elect a different grading option. To be awarded prior to June 2nd, students who applied to graduate this semester will need to elect a grading option for all of their available spring courses.
