400.1.5(F) FOSTERING UNDERGRADUATE STUDENT SUCCESS (FUSS) POLICY UPDATE

Withdrawals: *Course withdrawals taken during the 2020 spring semester, 2020 fall semester, or 2021 spring semester due to the COVID-19 pandemic shall be considered taken due to serious extenuating circumstances.*

Grade Replacements: *Courses taken during the 2020 spring semester, 2020 fall semester, or 2021 spring semester shall not count against the maximum number of allowable exclusions/replacements due to the impacts of COVID-19.*

The Provost has requested that programs, with repeat attempt rules in place for progression courses, DO NOT count W grades taken in fall 2020 as attempts under the repeat attempt rules.

PASS/NO CREDIT (P/N) GRADING PROVISION FOR FALL 2020 APPROVED (UNDERGRADUATE COURSES ONLY)

While the details are still being worked out as to how this option will unfold, the specifics are still being worked out. A few ideas being considered:

1. Certain critical progression courses will be excluded. Should this be approved, colleges will be contacted for help in identifying these.
2. Two (2) course election limit
3. P/N election prior to knowing the final standard grade in the course.

First half-term courses, having already awarded grades, and early entry graduate courses will be ineligible for P/N election. The 19 students who elected P/N prior to the drop/add deadline and the 1,211 students who are enrolled in courses designed with P/N grading will be able to elect two (2) additional courses for P/N, if the two (2) course limit is approved.

The Office of the Registrar and OneIT have already begun to brainstorm how this will be implemented. The Office of the Registrar has also requested to extend the open grading window to open on December 15, instead of November 30 to allow more time for development of an election tool. No decision has been made at this point. As details are approved, we will ensure that this fall's election tool meets the established needs of the University.
